Temporary Official Court Reporter Allocation

With the elimination of the funding for temporary official court reporters to fill in for sick leave, surgery, maternity leave or emergency situations, the 141 State of Missouri officials and their Circuit Judges have had to coordinate and work together as never before.

The Circuit Court Budget Committee (CCBC) has received several special requests for funding and very few have been granted. The CCBC looks into many things when considering requests. Some of the things that the CCBC takes into account are the OSCA work study, the OSCA case reports, how many reporters are in that Circuit, how busy is the Circuit, how close are the adjoining Circuits, how busy are the adjoining Circuits, is the case or time period something that can be worked around, the time period of the request.

One question has been asked by several official court reporters, and that is WHY do official court reporters NOT get sick leave? WHY do official court reporters NOT get vacation? WHY are official court reporters treated differently than other State employees? WHY isn't the MCRA doing anything to get official court reporters sick leave and vacation?

The answer is very simple. For every decision that is made, there are consequences that have to be accepted. We see it every day in court, but when it affects us directly and personally it is difficult to see the forest through the trees.

A decision was made when court reporters were originally hired that they would be statutory employees of the State. This issue was revisited approximately 10 years ago when a salary grade was offered to official court reporters by the State. This article will not go into the specifics of that salary grade, but the MCRA had meetings and completed a survey of all official court reporters at that time. It was the decision of the majority of the official court reporters that they wished to remain statutory

employees under the existing system.

As statutory employees the official court reporter works solely at the discretion and pleasure of their Circuit Judge. They cannot be pooled without the permission of their own Judge. They are not bound by the rules of non-statutory employees, but take their instructions and directions from their Judge. So when their judge takes vacation, goes to school, has a doctor's appointment, is sick or is unavailable to work, their court reporter has that time to work on transcripts or to use as vacation.

Along with that benefit—and most people believe that to be an

extremely wonderful benefit—comes consequences. Official court reporters DO receive health benefits, cafeteria plan, deferred compensation plan, a pension plan, and life insurance. However, official court reporters do not receive vacation nor do they receive sick or maternity leave. These benefits and consequences are the same for all statutory employees, including all the Judges in our State.

The legislative allocation of funds is as a result of RSMo 485.075: Appointment of temporary court reporter, when—compensation—duration. 485.075. In the absence of the official reporter of any circuit

judge because of illness or physical incapacity to perform his duties, the judge may appoint a temporary reporter, who shall perform the same duties and receive the same compensation as provided for the regular reporter for the time served by the appointee as temporary reporter, to be paid upon certification of the judge making such appointment. No temporary appointment shall continue through more than thirty court days in any calendar year unless so ordered by the supreme court of this state.

This allocation has always been requested and approved by the legislature until recently when our budget became challenging. At that time it was the consensus of most Circuit Judges and official court reporters that they would rather sacrifice the "incapacitated" funding allocation than lose any official court reporter positions.

It is really incumbent on each of us to work through and sacrifice during these tough economic times. We have been successful in not losing any official court reporter positions to-date. If you truly have a situation where it is necessary to make a request to the CCBC for special funding, please do not hesitate to have your Judge along with the Presiding Judge of your Circuit provide a written request to the CCBC.

Complaining and threats to sue the State for vacation and/or sick and maternity leave provide no benefit but invites the Supreme Court, the State and the CCBC to rethink how our employment should be categorized.

When the economy is more stable and the threat of losing official court reporter positions is diminished, MCRA, along with the CCBC, will pursue getting the sick leave and maternity leave allocation reinstated. Nothing Takes the Place of Persistence

Persistence is a constant: a constant drive, a constant will, and a constant presence. It is something done continually, without fail, and without giving up. Persistence is fighting against odds that are stacked against someone and against challenges in their life that they may encounter. Persistence is the key ingredient of success.

To succeed in anything, a person must continually strive to keep the endeavor alive and growing. Even someone who is naturally talented must continue to hone their craft if they want to take it to the next level. Unforeseen events and missteps along the way happen to everyone. It is up to that person to make something positive out of the misfortune.

This is something I learned all too well this past fall. On October 1 my apartment burned down. I knew I had lost just about everything I owned. The damage was so severe that for the first week the only people allowed inside were the restoration crew. I had no idea what, if any, of my possessions had made it through intact. Two of the things I worried about most were my steno writer and my computer. I was into my third semester of school and knew that if I had to take a significant amount of time off in order to save enough money to purchase another writer, I would set myself back. To know that all of those pre-

cious hours could possibly have been wasted sickened me.

A week later my beloved grandmother passed away. I had only just

begun the cleanout of the storage space the restoration workers had thrown all of my possessions into – whether burned, water damaged, or unharmed. This family tragedy not only devastated me, but also set me back another week on my clean-out. While dealing with these life-altering

events that had been so suddenly thrust upon me, I knew that I could not give up on my dream of becoming a court reporter. I knew how proud my grandmother was of me taking this step in my life, and I certainly did not want to let her down. I began contacting court reporters and other people in the judicial system that I knew to see if they had anything I could borrow if my writer would not work.

About four weeks after the fire, I was finally able to unearth both my computer and my writer out of the pile of what was now mostly moldy junk. Wrapped up in a tarp was a mass of cables and equipment. I rushed to my new home, plugged everything in, and held my breath. As soon as I saw the first lights come on, I was able to exhale. The equipment had made it through undamaged. I was now more determined than ever finish my schooling.

After not being able to practice for almost a month, I had a lot of catching up to do. In fact, I still feel like I am catching up. However, my instructor and people like the ladies I met while participating in the MCRA legislative cookie drop keep me motivated. Knowing my daughter is watching me and learning from my actions also inspires me to succeed.

I know that with persistence, one day I will achieve my goal. I will be able to live my dream. I will make my grandmother, my family, and – most importantly – myself proud. With persistence, I will become a court reporter.

You can be happy or sad, it doesn't matter. You get to choose. You can go this way or that way. You get to choose. There's not one right path. But along the way, think, speak and do that which brings you joy or at least what makes you feel a little better.

Cookin' with MCRA

Oatmeal-Cherry Scones



Ingredients

- ¼ cup orange juice
- ¼ cup water
- 1 cup dried cherries
- 2 cups rolled oats
- 3 cups all-purpose flour
- 1 tsp. salt
- 2 tsp. baking powder
- 1 tsp. baking soda
- 3 Tbsp. white sugar
- 1 cup unsalted butter, cubed
- 1 ½ cups cold milk

Directions

1. Preheat the oven to 375 degrees.
2. Heat orange juice and water in a small pan. Add cherries and simmer the mixture for one minute, then let it sit until it cools slightly.
3. In a food processor, grind the oats with the flour, salt, baking powder, baking soda and sugar. Add butter. Run the machine in short spurts until the mixture has the consistency of sand. Transfer mixture to a large mixing bowl.
4. Add milk and orange/cherry mixture to the large mixing bowl. Stir until it holds together.
5. Form the dough into a large ball, adding a bit of milk if necessary. Press or roll out the ball of dough until it is one inch thick. Cut the dough into 16 squares or triangles.
6. Bake the scones on an ungreased baking sheet for 15 minutes or until they are lightly browned on the edges.

After departing the U.S. Marshal Service office, the group returned to Judge Perry's courtroom to witness a Supervised Revocation Hearing. While in Judge Perry's courtroom, the students were able to observe a U.S. Marshal escorting a prisoner into the courtroom.

The group then reported to the Jury Assembly Room for a delicious lunch provided by Russo Catering. However, the real treat was being able to meet the President of the



NCRA, Melanie Humphrey-Sonntag. The students were extremely honored to have Melanie join them and be able to ask her questions.

After lunch, the field trip attendees participated in a live NCRA Student Forum Online Chat with other NCRA staff and students across the country. A day in the life...

And what a day we had! Once again with dedication, the MOCRA Student Affairs Committee planned and hosted an amazing day at the federal courts building in downtown St Louis for court reporting students in the area. The day not only gave us a special view of a “day in the life” of an official federal court reporter but also included a special tour of the U.S. Marshall’s office, a visit to the Federal Court of Appeals, a sentencing hearing, and an online student chat hosted by NCRA.

We started the day in the Court of Appeals. Here we actually got to see and hear an appeals argument in front of three federal judges. But the craziest part was that no court reporter resides in these hearings. Lawyers come to this court for a very condensed argument supporting their appeal. They aren’t arguing the facts but are more trying to drive home their case’s merit based on previous case law. The plaintiff’s attorney goes first and then the defense argues the merits of that case. Then the plaintiff’s attorney rebuts. Each attorney is limited to a specific timeframe for argument. The matter is then closed, awaiting a decision of the court. It is fascinating just how deliberate and brief the appeal argument process actually is.

Next we were led down to the U.S. Marshal’s office for a tour. We saw their offices and their “equipment” room containing everything from bulletproof shields—with and without lights—to billy clubs of all sorts to helmets to bulletproof vests and various other items they use to protect themselves from the really

“bad guys” they tend to arrest. We also learned that these marshals’ main job is to arrest people. They operate under no specific jurisdiction other than within the U.S. Their jobs remain very dangerous, as they do much more than just protect someone in protective custody.

We then visited the courtroom of U.S. District Court Judge Katherine Perry and her court reporter, Terri Hopwood, RMR, CRR. Judge Perry spoke to us and gave us a complete “tour” of the courtroom and all of the “bells and whistles” which technology affords her courtroom. Terri also gave us her full perspective on court reporting for a federal judge.

Next we received a “Cliff Notes” version of the U.S. Court of Appeals process. It was fascinating to hear from beginning to end what happens when an attorney appeals the case after arguing in the U.S. District Courts. The court’s clerk gave us this perspective along with the daunting task of how he chooses just so many cases among thousands requesting a chance to be heard. What struck many of us was the power this clerk has in making these decisions. Through observing him, we could see just how intelligent he is.

Then it was back to Judge Perry’s courtroom for a sentencing hearing. The hearing, both heart-breaking and sobering, fascinated many of us. It showed us the true meaning of being “put away” for a crime committed. The defendant entered court not knowing his sentence and by the end of the short hearing, he left, again in shackles, heading to jail for the next



five years as a repeat offender. His pregnant girlfriend attended the trial as well...that was the heart-breaking part.

Finally, with our day coming to an end, we grabbed lunch, donated by Russo Catering Services. Over lunch we were treated with a visit from NCRA president, Melanie Humphrey-Sonntag. Her story and success provided great insights for all. She came that day especially to support the online chat hosted by NCRA for students. The format that day was a Q & A discussion of an actual “Day in the Life of a Court Reporter.” This perspective came from Debbie Kriegshauser, RMR, CRR, FAPR, CLVS. Her answers stenotyped by none other than our NCRA’s president. (For those that attended the MOCRA convention held in October 2010 in St. Louis, Debbie’s day was much more professional than the role-play she exhibited that day!)

As our “day in the life” of an official court reporter ended, I was personally quite inspired by the amazing reporters and people I had met. I thoughtfully walked home, reinvigorated to my dedication of becoming a court reporter.
